Keynote Speaker

Darren L. Johnson, MD

Dr. Johnson is currently Professor and Chairman of the Department of Orthopaedic Surgery at the University of Kentucky. He is also Director of Sports Medicine and Program Director of the accredited fellowship program in Sports Medicine. He is the head team orthopaedic surgeon to the UK Wildcats. Dr. Johnson received his MD degree at UCLA and completed his orthopaedic residency at the University of Southern California, followed by a fellowship in sports medicine and shoulder surgery at the University of Pittsburgh. He was selected in 1995, by the AOA, as a John Fahey North American Traveling Fellow and later in 1997, by the AOSSM-ESSKA, as a Traveling Fellow. He has served on the Board of Directors of the American Academy of Orthopaedic Surgeons. He currently serves on many national committees including the American Orthopaedic Society for Sports Medicine, Arthroscopy Association of North America and American Orthopaedic Association. His published work includes more than 90 peer-reviewed manuscripts and over 20 book chapters. Dr. Johnson has presented at many national and international meetings on varied complex topics related to knee and shoulder problems. He has been annually selected as one of the "Best Doctors in America" by Castle Connelly and as one of the "Top Doctors" in America.



Thomas P. Sculco, MD

Thomas P. Sculco, MD, Surgeon-in-Chief and Korein-Wilson Professor of Orthopaedic Surgery at the Hospital for Surgical Care in New York, NY. Dr. Thomas Sculco is also the Chairman of the Department of Orthopaedic Surgery and a Professor of Orthopaedic Surgery at Weill Cornell Medical College. He has written more than 235 papers and 64 chapters, and has presented over 540 papers on orthopaedic surgery and the surgical treatment of arthritis. He was included in New York Magazine's 2009 and 2010 list of "Best Doctors in New York."
